(a) Age Limit for direct recruits:

18 to 30 years as on 01/07/2024 for UR, for Government Servants up to 40 years in accordance with the instructions or orders issued by Central Government and for Ex-Serviceman upto a maximum of 3 years after deduction of the Military Service rendered from the actual age.

(b) Educational & other qualifications for direct recruits:

- A Certificate in the Motor Vehicle Mechanic trade from any Technical Institution recognized by the Govt. OR VIII Std. passed with experience of one year in the Motor Vehicle Mechanic trade.
- ii. The candidate who applies for the post of Motor Vehicle Mechanic should possess a valid Driving Licence (HMV) to drive any vehicle in service in order to test it.

2. METHOD OF SELECTION:-

Selection of Motor Vehicle Mechanic shall be made from, amongst the candidates possessing the requisite qualifications and valid driving licence by means of Competitive Trade Test. The date and venue of the test with syllabus will along with the hall permits. No intimation will be sent in respect of other applicants who are not eligible.

- (e) Driving Licence as indicated at SI. No. 1 (b) (ii).
